<u>Superintendent's Report:</u> Have completed the township piggy back brining and the county primaries are done for now. No grading on Victory Corners Road until the 3rd culvert is placed which is due to arrive today and will be placed next Monday. All the stumps are out. The tree crew finished working on Victory Corners Road and have also been removing dead trees. The Cat Excavator is working in Custer Township on a ditching project and also a parking area in Hamlin township on Duneview. Some Aggregate patching and cold patching. Some mowing. The new mower will be in next week. Extra help in the shop. Will be placing some clay and 600 yards of gravel on Nurenburg Road. Halliday Sand & Gravel have processed the gravel and will be working on sand.

- Hansen Rd, W. of Gordon Rd to 0.8 mi W of US-31: Awaiting several approvals. GI revisions being addressed. (\$485K STP, \$300K State D).
- 2017 Pavement Marking: South end of County Project has accepted by MDOT and submitted for Obligation Authority.
- Stephens Rd over Big Sauble Bridge: Obligation Authority Request has been submitted. Letting Date not yet identified. (Estimate: \$812,100)
- Decker/Stephens Rds over S Br Lincoln River/Frog Paradise Drain: Obligation Authority Request has been submitted. Letting Date not yet identified. (Estimate: \$637,500)

- Brine Pond Update: Several phone calls have been held between MCRCSIP counsel, ours and Gourmet Mushroom, Inc, regarding insurance and liability limitations and the extent requested. Initial feedback from the DEQ is positive regarding the repurposing of the lagoon although they are further reviewing it. Investigating the existing liner material and repair methods.
