At a meeting of the Board of County Road Commissioners of the County of Mason, Michigan, held at the office of the County Road Commission on U. S. Highway 10 in the City of Scottville in said County at 10 O'clock A.M., May 20, 1948, pursuant to the order of said Commissioners dated April 20, 1948.

Now Therefore, after due consideration, this Board, by resolution and unanimous action, under the statute in such case made and provided, does ascertain and determine that it is necessary and advisable, and does determine and order that:
