Englebrecht promised him that something would be done abou it but as of Sept. 11, 1961, when he again called the office, nothing had been done. Mgr. Lunde says that the Supt. proposed to take a bulldozer up there, but he thought it would only make matters worse and this action was stopped. The commissioners and Mgr. then too an inspection trip up there and their decision was that it did not need further trimming of trees and if anything was to be done on that road it would have to be at the rest and at cost to the Twp. Bd. Mr. Koselski was notified of this by a copy of a letter which was sent to the Grant Twp. Supervisor. Mr. Helminiak expressed great surprise that the commission and Mr. Lunde did no know of the Twp's. willingness to pay for this work since this was discussed in one of their twp. meetings and the clerk was supposed to contact Mr. Lunde and advise him of this matter. Mgr. Lunde says the clerk did call him at his home when he was absent and when he called back he got no answer, and therefore assumed that she would call later at the office.

They want an estimate of the work necessary to make this road meet the adequate specifical tions such such a local road. They would not specifically name an amount they were willing to contribute, since they felt this would limit Engr. Lunde in making an estimate of the necessary work, however, mention was made of \$1,000., 1200., and \$1500. as a possible contributions. The commissioners and Engr. Lunde adjourn at noon for lunch are are to meet this Grant group at 2 P.M. at the location of the road in question.

Grant Supervisor also mentioned the matter of notice regarding the closing of the Grant Twp. dump which has been in the County owned pit for a number of years. Also about the notice for the dump to be cleaned up within 15 days from date of letter or the road commission would do it and charge them for it. Sup. Helminiak claims he did have this done at the cost of \$32.00 to the Twp. and he questions the criticism of its condition. He also asks the possibility of the road commission selling this property to the township so that they might continue this as a dump. This suggestion meets with complete silence. He asks if there is ANY POSSIBILITY of such a sale and absolutely no indication is given of the reaction to this question.

Commission readjourns at 4:00 P.M. reporting their inspection trip to Meade Twp., the new blacktop road north of Freesoil, to Koselski road in Grant Twp., also the dump in Grant Twp.; Victory Twp., and Sherman S reet in Hamlin Twp. Commissioners report that the Grant Twp. dump has NOT been cleaned up since their previous visit in spite of the claim of the Supervisor to have spent money in doing so.

Mgr. presents the agreement for the 150 cu. yds. of gravel which was put on the road to the Gareld Hilden place in Freesoil Twp. Althout the Freesoil Twp. Board had signed this agreement, the commission had refused to do so because the price of the gravel was not on same. Since this was to be done at a 100% cost to the Twp. the price could not be put on at that time until the job was finished. The figures which were charged to the Project No. S-1161 brought the cost of the job to \$271.72 which was only \$1.81 per cu. yd., which seemed too low for thelength of the haul. The clerk then checked the time slips and found that the spreading charges had not been charged to the project number as they should have been and when this was added the price of the gravel was \$1.97 per cu. yd. This had been charged to Freesoil Maintenance. The commission signed the agreement.

Oct. 12, cont'd - In the afternoon of Oct. 12, the commissioners and the engineer made a tour of southern part of county visiting a prospective source of gravel in Oceana County, went to the Townkine Rd. between Summit and Riverton; Lakeshore Road where gravel is being screen from the Peterson pit and also looked at the Vorac Pit which proved to be a dud and very expensive for the gravel obtained; also inspected the culv. project at Swan Creek.

Oct. 13, 1961 - During the session of the Bd. of Supervisors, three members of the Road and Bridge Committee, Chairman Ingersoll, Don Villadsen and Leo Monton, visited the Road Commission Office, but since the regular meeting day had been changed from Fri. to Thurs, that week, they were unable to see the commissioners.

They asked a number of questions of the clerk, and were shown various phases of her work, however, the questions in which they were most interest, that is the cost of a mile of blacktop, etc. were referred to the engineer-manager since that is his department and this information has not been mequired of the clerk, since every job will vary depending on the conditions prevailing on that certain road.

They however did inquire of Mason County's participation in Federal Aid and were informed on this score by the clerk.

Oct. 20, 1961 - Regular meeting held with all commissioners present. Chairman signed payroll checks and voucher for Michigan Hospital Service. Due to lack of funds, no other accounts payable were signed.

Clerk requested a clarification of the agreement with Joe O'Farrell who had inquired as to when he would be paid for the gravel taken from his pit in March and May, 1961. but when he was given a check for the March gravel in the amount of \$586.50 for 3,910 cu. yds. at 15¢ per cu. yd., he did not want same. He wanted full payment in 1962 and some agreement as to payment for his sand.

Motion by Gamertsfelder, supported by Peterson, and confirmed by Eddy, to pay Joe O'Farrell 15¢ per cu. yd. for gravel removed by the Mason County Road Commission from his pit, but that any other material removed while processing this gravel will be replaced by the Mason County Road Commission with waste sand from the Jones Pit durir stripping operations,

Oct. 27, 1961 - Regular meeting held with all commissioners present, also Engr.-Mgr. Lunde and Robert Smith of Smith and Eddy Ins. Co.

Motion by Peterson, supported by Gamertsfelder, authorizing Chairman to sign Statement of Values on buildings and contents and Agent of Record letter for Robert Smith. Smith will send necessary forms in; and company adjuster will be in to determine value of buildings and contents; then when Smith gets all premiums together, he will come up and see the commission again.

Motion by Gamertsfelder, supported by Peterson, to install safety valve on big gas tank. Manager to get details and price from Seaman Co., in Grand Rapids.

While Smith was here he brought out several points about troubles which might arise for the County from people doing work for Road Commission without assurance that they themselves carry sufficient workman's compensation coverage and liability insurance. A certificate of insurance should be demanded bycas before hiring such outside help, otherwise if they did not have coverage the liability for any occurrence would revert to the Road Commission coverage increasing our premiums.

Mention was also made at this time of the desirability of requiring a physical examination before any new employee is hired either for temporary work, or prospective permanent employment. This was unanimously passed upon motion by Gamertsfelder, supported by Peterson, confirmed by Eddy. Mgr. or Clerk to contact doctors on their willingness to act as company doctor, and also getr a form suitable for this purpose, which will satisfy future necessary medical information, and have a fee set by the doctor for this examination.

Mgr. discusses the possibility of an open-sided pole-shed for housing some of the equipment, especially the motor-graders and larger equipment when equipped with snow-plows which cannot be accommodated in the present buildings. This pole-shed will have no heat in the building, however, there will be electric engine heaters installed so that this equipment will be ready to go in the morning. Commissioner Peterson also brings up the matter that he would like to see additional buildings at each end of the county, north and south, to house some of the equipment working in that area so that there would not be so much wasted time in getting the equipment to the site of operations in the morning and not having to leave the job so early at night. This received favorable acclaim from the other two commissioners and will receive further consideration when funds allow.

Manager then gave Secretary resume of the inspection trip taken by the commission on the afternoon of Oct. 20, 1961 as follows:-

(1) Primary roads in Riverton Twp. were looked over as a part of the construction program for 1962. Discussion centered on:-

(a) Scottville road, on east side of Section 25, in which there is 3/4 mile o:

rough, poor subgrade and bad snow-drifting conditions.

(b) On Chauvez Road, the east 1/2 mile on north side of Section 5, very narrow

clay base, and is in poor condition.

(c) Stiles road, bet. Sec. 3 & 4, a paved road that is difficult to maintain, should be sand-cushioned entire length, salvaged materials for surfacing, and double-sealed.

No definite plans are yet made for any of the above locations.

(2) Commission then proceeded on over to Lakeshore Drive to Peterson Gravel Pit ar then up into P.M. Twp., then across on Dewey Road over to Stiles Rd. and on Stiles Road from Hansen Road, south to US-10 and 31; this mile and a half show considerable edge failure, is very narrow and should be widened and some base corrections made in 1962.

Discussed the failure of the Vorac Pit to prove out. Clerk asks how this expensive project should be charged since it would seem unfair to charge this failure which produced less than 100 cu. yds. against the overall gravel costs for the year. Perhaps this should be charged to Distributive expense as a Gravel Test only. Clerwill request information on this type of charge at the next Clerk's meeting which she attends.

- (1) The commission went on the following tour after lunch, reconvening at 4:00 P.M:—
 Went to Peterson Pit; inspected the new blacktop on the Hawley Rd; at junction of
 Hawley Rd. and Ordway Road, east of the corner, the swamp fill has sagged danger—
 ously. If weather and time permits, this will be raised with sand, and regravelled
 as soon as possible; likewise west of this junction a similar dangerous condition
 exists and shall be repaired and regraded as soon as other commitments are complete
- (2) Visited the Blue Lake resort where new road around the lake is being built by contractor;
- (3) Visited Ford Lake site where Conserv. Dept. wants to put a pike-spawning pond; road needs raising and same will have to be done at 100% cost to the Twp. of Sheridan or local interests;

(4) Inspected culvert on Tuttle Road in Custer Twp. (Peterson mantions that Schulz at Amber Corners also needs culvert work.

Upon motion by Peterson, supported by Gamertsfelder, the meeting was adjourned at 4:45 P.M.

Opened bids on coal for winter supply; Abrahamson-Nerheim quoted \$14.95 per tonand L. A. Hawley Co., \$13.75 per ton for commercial stoker coal with similar statistics. This is 15¢ per ton cheaper than Hawley bid which was accepted last year. Motion by Peterson, supported by Gamertsfelder to accept the low bid of L. A. Hawley and Son Co., this was confirmed by Eddy.

At 1:30 P.M., the Black Creek drainage project area represented by Bob Amsterberg, Russell Mavis, Robert Hasenbank, and M. M. Tyndall, met with the commission to request their co-operation in setting up this program. Some details on culvert were discussed with nothing definite decided. Commission expended their co-operation to the project in general but did not take a specific stand on any financial commitments.

Motion by Gamertsfelder, supported by Peterson, to adjourn at 3:35 P.M.

Nov. 10, 1961 - Regular meeting held with all commissioners present. Minutes of previous meeting read by Secretary and approved as read. Accounts payable vouchers were signed in the amount of \$28,762.99.

Ray Stakenas was in to see commission about the flooding around his home on the Fountain Rd., west, each spring. About ten feet of water comes from Lincoln River. Says it was floodfevery year except last spring. Peterson asks if there is a county drain there. Engr. Lunde asks him how much damage it does. Stakenas says it backs up to the Lincoln River drain. Lunde then calls Drain Commissioner Tyndall on phone and finds out that there is no county drain there, that the ditch there was dug by the WPA and therefore no funds were collected which would now be available for cleaning said drain; at that time there was only a verbal agreement with the property owners, no money was assessed and it is not a county drain. The drain becomes plugged by cattle and hogs wallowing in there, but you can't fence it off to keep cattle and hogs out of there. Commissioners agree to take a look at this situation after lunch and agree to meet Stakenas there. Stakenas says he has looked into this culvert and there is a hole there which extends under the road and road may cave in if something is not done.

Letter is read by clerk which is from Mich. Mutual Liability Ins. Co. to Sam Massie of the Massie and Allaben firm who is handling the Jepsen case for Michigan Mutual. Massie has previously asked for the thinking of the commission on settlement of this matter, and Mich. Mutual Attn'y mentions that perhaps \$1,000. would be better than letting the case go to a jury if they would take that. Commission says to advise Mich. Mutual that they feel they are handling this case satisfactorily and they will leave it entirely in their hands. The prospect of a \$1000. settlement sounds good.

Engr. Lunde then asks the commission if in view of the 20th payday falling on Monda; if the meeting of the 17th on F iday shouldn't be skipped. This does not meet with favor, and no motion is made and Peterson says more on this matter will be taken up after lunch.

Engr. brings up the matter of the culvert on Dennis Rd. in Victory Twp. He suggests a concrete deck on this culvert at an estimated cost of \$2620; the headwalls must be extended out; all new steel in the deck; $19\frac{1}{2}$ feet long. Sup. Pratt is expecting to ask for some participation from the road commission. Steel work alone is about \$1600. It is also suggested that curbs should be poured on both sides and with some guard rail, possibly could slide along with this for a while.

Letter is read from Fountain Chamber of Commerce re the pike spawning pond previously requested by the Dept. of Conservation. Engr. reads letter to commission and recommends that this be done for them because it needs raising about 3 feet anyway No mention of participation. Leave same tube but raise the road at least 2 feet. Gamertsfelder says, put in a fill, but do not let them use our road for a dam. More investigation of this matter necessary. Clerk instructed to reply to them letter from the Fountain C. of C. and ask them for complete construction details on this project.

Engr. brings up the matter of the Pole Barn previously discussed; wants 8 stalls; 14-foot width, open on south side and up against the steel storage building on the north; 40' x 120' with no doors; but will have two ends. Peterson NOT in favor of this building not having doors.

Commissioner Peterson voices disfavor of state contract maintenance work, and also brings up the subject of road commission paying insurance for storing state park tables in the barn purchased from Widmark. Policy shows that no contents are covered, but Mr. Peterson insists that Bob Smith, insurance agent, said that road commission were covering these with \$50. each value. Commissioners then go to lunk during which time clerk checks this insurance matter with Bob Smith and finds that during his visit at the previous meeting, he had only mentioned covering these tables as a recommendation for future reference, he did not intend to imply that the road commission were doing so at this time.

After lunch, commission and engineer take the following tour before returning to the office:-

Drave over the east half of the Sugar Grove Rd. contract grading job and noted that work is progressing rapidly in spite of wet weather. All of this section of the job is in sand; also traversed part of the grading on the west half of this job in Victory Twp. The west mile and one quarter is in clay grade and wet weather has slowed up the work. However, it was noted that most of the road culverts are in and work is progressing very well.

Met with Ray Stakenas who lives approx. 1/2 mile west of King's Corners on the Fountain Road. The complaint here is that the crossroad culvert is too small to handle the high water. After considerable discussion, the Commission requested cost figures for the materials and installation of a 72" culvert in place of the existing 36" culvert.

Drove in on a dead end road bet. Sec. 15 & 22, of Grant Twp. to the Koselski residence. There is an agreement with Grant Twp. on file to clear the brush on this road and shape it up. The brush has been cut and removed, the stumps have been removed, but high water has prevented any additional work. It is requested that this road be bladed with the motorgrader and consider the possibility of hauling in some fill sand with the scraper.

Stopped at the Dennis Road culvert in Sec. 8 of Victory Twp, details of the proposed repairs of this culvert were explained to the commission. The Engr. also contacted the Supervisor of Victory Twp., giving him the necessary data so that he could meet with his township board for study of the problem of financing a rebuilt culvert.

Drove thru! Linlook Park in P.M. Twp. Found that the sand ridge in the road that was crowding the Parker B. Francis property, had been partially removed by other people who are erecting a new residence on the south side of this street. However, road commission should remove additional sand from the street and cover with top-dirt to stop erosion from wind and permit travel on the street.

Returned to the office by way of the Chauvez road, where the bridge crew were finishing up the steel beam guard rail job at Swan Creek bridge crossing.

Upon return of the commission to the office, the facts of the insurance matter re coverage on state park tables was presented to Mr. Peterson, but he remains unconvinced. He also wagers 25¢ with the clerk on the name of one of the locations visited on their tour, he and Com. Gamertsfelder maintaining the name to be Linwood Park and clerk declaring it to be Linlook Park. Engr. cinches argument by getting map showing clerk to be correct and she collects her wager. Peterson perturbed:

For the nth time, the discussion resumes about the meeting day being moved up to the 20th with no meeting on Friday, and Com. Peterson and Engr. Lunde cut each other to ribbons on this issue. Meeting apparently to remain on the 17th AND again on the 20th.

Meeting adjourned on motion by Gamertsfelder and supported by Peterson, at 4:30 P.1

Discussions were held on the following subjects:—Regarding the 72" culvert which is contemplated to replace the present culvert on the Fountain Road, west, as complained about by Ray Stakenas at meeting of Nov. 10th; also mention road south of Hamlin School; Engr.—Mgr. also brings up the necessity of acquiring two addition al side plows to be on the safe side of having sufficient snow-removal equipment. Engineer had called the Contractor's Machinery Co. that morning, getting a price over the phone of \$925.00 each.

John Davis, from Hamlin Twp., appeared before the board to protest the terrible condition of the Quarterline Road, and also parts of the Townkine Road. Says the chuckholes are very bad and something must be done.

Mgr. quotes price obtained from Graham Brimhall on the pole barn being considered. Materials only for the stalls, sides, etc. would be \$2344; roofing from Kiefer's would be about \$600., making a total materials cost of around \$3,200.; if constructed by others, it would be \$4,950.00.

Mgr. reads a letter from Attorney VanDuzer regarding the Carl Smith Property at Round Lake. Need more right-of-way on part of this road and Smith is unwilling to give any more on the side toward the lake. Wants this road to be taken out of Primary system and the Primary road established behind his property from Oak Openings corner. Commission will view this situation before taking a stand on the matter.

Commissioners and Engr.-Mgr. drove over the following roads to check conditions:North on Custer road to the Beyer Road; drove west on the Beyer road to US-31, a
distance of three miles, rather muddy but passable in the swamps. Ditching work
has been finished on the Beyer Road. Drove the Quarterline Road from the Townline
north; this road is rough but quite passable; inspected the roads in Freesoil and
Meade Twpw, that has been clayed heavy and re-shaped this past season; they all
looked good and were in fine shape. Stopped at Jones Pit to see what gravel was
available and then drove to the Round Lake grading job. This clay grade is in
pretty rough shape; some sand should be hauled in at the north end to help the
these people out from their driveway to the road.

Received a call on the raisexfx radio from the office to meet Mr. Grimpe at Ford Lake; had a maeting with him and a Mr. Gedman at the location of the proposed pike-rearing pond. Necessity of raising the road at this culvert crossing on the

southwest side of Ford Lake was explained to the commissioners; this matter tabled until Monday, November 20; returned to the office by gravelled side roads.

Dec. 1, 1961 - Regular meeting held with all commissioners present. Minutes of previous meeting read by Secretary and approved as read. Secretary also read to Commission letter from the attorneys who have been handling the Jepsen damage suit against the Road Commission for the Michigan Mutual Liability Co. who have this coverage. The attorneys, Allaben and Massie, advise that the \$1,000. offered as a complete settlement of the original \$50,000. suit started, has been accepted by the plaintiffs. Since this suit named both the husband and wife as plaintiffs, the settlement is to be made \$600. to the wife, sustaining the claimed injuries, and \$400. to the husband which will required signatures of both and thereby preclude any possible further action on the part of either.

Supervisor Irving Pratt of Victory Twp. was in to talk about the culvert which they want placed on the Dennis Road in S ction 8 of Victory Twp. Altho' they have the estimate given to them on Nov. 7, 1961 by Engr. Lunde, it appears the board is unwilling to participate for the cost of the new materials. Engr. prepared this estimate with all new materials because of previous accusations that scrap material was being used. The materials, all new, would amount to approximately \$2,357.90; which would include a metal deck with asphalt surfacing; with concrete deck, materials would be \$1,911.50.

Comparing this with two previous similar jobs in P.M. and Riverton Twps., statistic: show that Twps. paid the cost of the materials 100%, and one ran 53% of the total cost, with the other showing materials to be 59% of the total cost.

Discussion then becomes strictly Twp. management problems between Supervisor Pratt and Commissioner Peterson who lives in that Twp. and was the former Supervisor.

Some discussion on cutting down the cost by using salwage materials. Engr. asked to look the situation over and see how costs could be cut. Some mention made that they would be willing to go along with \$1000. without question, which amount is les: than 50% of the material costs only on the original estimate with all new materials

Supervisor Pratt mentions that they want to spend some of their road money to have some holes patch here and there in the Twp. with Road Commission doing new ditching where these spots are annual bad. Commissiones Peterson and Gamertsfelder object to this type of particpation.

After lunch commissioners and engineer take the following tour of the county before returning to the office:-

(1) Went up on Sugar Grove grading job.

During absence of Commissioners and Engr., Supervisor Ingersoll of P.M. Twp. was in with several requests.

(1) On Oakwood Dr. just off N. Rath Avenue where fly-ash from Dow's was applied

last summer, the road is full of chuckholes.

(2) At the entrace to the Cartier and Ludington Public School property just off Bryant Road, bet. Lincoln Rd. and Lakewood Dr., someone has placed a big log chain across bet. two trees. This was reported to Sup. Ingersoll by Mrs. Cecil Morse who lives directly across from this location, asking him if anyone had a right to close off this road.

(3) At Sixth St. where it comes out from Ludington onto US-31, there is a stop sign but Twp. Bd. thinks there should also be a line painted across Sixth Street showing where to stop, since encroachments on US-31 in making this stop have

nearly caused several and accidents.

(4) There was a stop sign at the west end of Iris Rd., and someone has moved it so it is on Lakeshore Drive around the corner to the north. Two. Board feels then should be a sign where this one is now, but also that another should be reestablished at the west end of the Iris Road.

(These requested items were recorded by clerk and given to the Engr.-Mgr. Commission and Engr. were contacted by radio in regard to the barricade matter just off Bryant Rd. but they did not visit this location as anticipated. Engr. later visited this location and found that this is a private road and in no way involves the Road Com. nor the P.M. Twp. Board. Mr./Ingersoll was so advised on Monday, Dec. 4, 1961 by

December 5, 1961 - Regular meeting held with all commissioners present. Payroll checkers were signed by Chairman and thoroughly reviewed by Comrs. Peterson and Gamerts-felder. Minutes of the previous meeting were read by the Secretary and approved as read.

Engr. gives commission his estimate of cutting down cost on Dennis Road culvert in Victory Twp. Cuts the material cost by \$750., cutting job down to \$1,861.10. The salvage material to be used from the yard would not be charged for. Cannot reduce labor, but salvage material will reduce total cost.

Motion by Gamertsfelder, supported by Peterson, confirmed by Eddy, that \$1,000. be accepted as Victory Twp's participation on the Dennis Road culvert now estimated at \$1,861.10.

Free trimming permits are being requested for the coming year by Michigan Bell Telephone Co. and Consumers Bower Co. Engr. says no trouble has been encountered with them thus far, and Chairman is authorized to sign both permits.

Engr. asks for decision on paying W. E. Reader the balance of \$824.79 due on their account. This has been held up for an adjustment due to having to re-make these mowers for highway use. Credit of \$344.92 was allowed on the parts used, but Road Commission was to pay for the labor and some iron used in installation of these grass boards. Motion by Gamertsfelder, supported by Peterson, confirmed by Eddy, that this account be cleaned up immediately.

Also, the matter of the Cole Bros. account for repair on the John Deer Loader has been pending for some time, and this \$831.15 account balance is to be paid upon Motion by Peterson, and support by Gamertsfelder, with confirmation by Eddy. Vouchers for both of the above accounts were signed.

Engr. had request from Devere Sterley of Victory Twp. who lives on Victory Drive for permission to place a one-inch water-pipe under the road, and engineer gave him this permission.

Engr. gives commission information on tank vent with manhole on top with 6" safet valve from R. V. Seamsn Co. of Grand Rapids at \$60.00 approx, but not installed.

Engr. says Summit Twp. would like to have the following arrangement made regarding payment of the Sunset Lane (Montgomery Rd) extension on which more work was done than Summit expected. This bill amounted to \$1,012.50 and they will pay this if the Road Commission is willing to complete S-2461, which is clearning, grubbing at turnpiking in Section 26. In view of the fact that Summit Twp. has agreed to pay \$2000. or more upon completion of the seal-coating on Lakewood Rd. bet. Deren and Kistler Road, the commissioners decide to accept this agreement, requesting the Twp. to split this primary road money so as to cover the cost of doing Project No. S-2461, a local construction project, and then the balance to be applied on the Primary job.

Commissioner Eddy brings up the matter of trying to make the Freesoil Rd. bet. Freesoil and Meade Twps, a state highway. Peterson says this has been talked about for years, and nothing done. Eddy says Supervisor Hasenbank brought the matter up to him, but he did not know who brought it up to Hasenbank. Commission turns thumbs down on the idea feeling that it would reduce the Primary funds received by this county which are needed. Chairman asks clerk to notify Max Carey by phonat Freesoil that commission will NOT be meeting with him as tentatively set up.

Dec. 5, 1961 - continued.

Motion by Peterson, supported by Gamertsfelder, confirmed by Eddy, to put request for bids in Michigan Roads and Construction, to appear in the Dec. 9th issue, for a 14' snow plow blade to fit the Austin-Western motor-grader.

Engr. mentions sending two of the mechanics to the Peninsular Diesel school in Grand Rapids to be held the 11th and 12th and 13th and 14th of December. Commission says it would be a good idea. This is a two-day session only would not involve too much expense.

Engr. mentions repairs necessary on Tractor No. 50 and Chairman Eddy says he would not approve of another nickel being put into repairs on that machine since it was practically rebuilt only three years ago.

Engineer reviews 1961-1962 Road Program with Commission after lunch.

Motion by Gamertsfelder, supported by Peterson, confirmed by Eddy, to adjourn at 4:30 P.M.

Dec. 12, 1961 - Regular meeting held with all commissioners present. Secretary reads minutes of previous meeting and same are approved as read with clarification by Lunde as to the size of the vent for the gasoline tank and the price for same.

Engr. explains about the vent to be put on the gas tank as discussed on Dec. 5,196.

Peterson asks about Victory agreement on Dennis Rd. bridge, and Mgr. says he sent the papers with revisions to Irving Pratt, and hasn't heard anything from him.

Discussion on joint venture on bridge bet. Oceana and Mason County. Final tally sheet has been received from State Hwy. Dept. but they have divided it 50/50 including the approaches which were supposed to be the sole responsibility and expense of the Oceana Co. Rd. Com. Peterson makes motion, supported by Gamert: felder, it confirmed by Eddy that clerk notify Oceana to this effect.

Engr. then brings up the matter of the collision involving the 1958 Ford passenger car belonging to the commission which was run into by Mrs. Gilbert Cobb (Betty) at the intersection of Lakewood Drive and Rasmussen Road, on F iday 10:20 A.M., Dec. 8, 1961. License number of the car was WB 1861, a 1956 Buick.

They live on Route 2, Ludington, known as C-7. The husband is an oiler for the C & O carferries, and they have no insurance on their car. Estimate of repairs by Hallberg's Body Shop is \$178.09. Mgr. asks commission what they want to do about and Peterson says, sue for damages and see what can be gotten out of them, and then decide about fixing car.

Discussion about pole barn for housing equipment in winter. Peterson says it is too late to start this and it should now wait until spring, and he would like to see the quotations of the cost all in one lump sum, rather than piece-meal as it has so far been presented as one part from Graham Brimhall, roof from Kiefers, etc. with no estimate on labor.

Engineer brings up subject of Questionnaire received from the Co. Rd. Assoc. asking the feeling of the counties in regard to the prospective tie-in with the State Highway Department in a Cross-Monitoring system when their two-way radio system is set up throughout the State. This was tabled until more information could be obtained by the Engr. regarding cost of setting it up, maintenance of it, and antenaa for same.

Engr. brings up subject of Stokely's wanting to hook onto our tower for them to have a radio system. Commission says nothing doing. Rd. Commission is und civil defense program and could not be used in this way, also license forbids same.

Motion to adjourn at 5:00 P.M.
