The road commission ha done all they can to settle this matter. They put the ditch back along the road, down the center of which the Monton boys have again placed a fence.

Claire departs and calls back shortly to report that he has talked with Smith and he says Smith said the only way the road commission will get the land on the north side is to condemn, but he might agree to sell some on the south side.

Engr. Lunde asks Claire what the position of the road commission is in approving plat with private streets. There was some discussion on this at the last Senatorial meeting and different understandings of the information obtained. Some counties are approving plats and shutting their keyes to the fact that said streets do not meet the specifications of public streets; road commissions suggest r.o.w. width and specifications, but do not make them compulsory.

Motion is made by Comr. Biegalle, and supported by Comr. Voss, to sign the agreement with the Summit Twp. Board and Geo. L. The road commission may go in and get the R.O.W. and file same with Reg. of Deeds. Th twp. must pay for this.

Caldwell then concludes his visit with request for road commission to furnish him with two loads of gravel for the P.M. shrine.

Manager reported that both Dodge trucks were in Grand Rapids and should be here in about two weeks.

Letter from grievance committee requesting meeting with Road Commission. Letter is addressed to Supt. or Manager. Discussion. Manager is to answer letter. Manager read grievance procedure as written in working agreement. Comr. Biegalle says grievance should be in writing and discussion held to only written grievance or grievances.

Manager reports John Claire, Attorney, told him Muchigan Mutual Ins. Co. would pay two thirds of Sproul case. Comissioners feel that Claire should come up and explains ideas on this case. Manager called Claire's office and set up an appointment for I:30 P.M. at his office in Ludington.

Manager brought up Primary Road Construction program for next two years and also Federal Aid Program. This would be approximately 13 miles of plant mix: $-3\frac{1}{2}$ miles on the Fountain Road; $3\frac{1}{4}$ miles on the Custer Road; 3 miles of the Scottville Road; and 3 miles of the Chauvez Road. Grading would be done on 5 miles of the Scottville Road; ville Road; 2 miles on the Hawley Road; $1\frac{1}{2}$ miles on the Angling Road; 1 mile on the Chauvez Road, and 1 mile on the Millerton Road.
