Preliminary study was made of possible haul routes to the project. Subject to definite schedule by CPC as to which roads they will be using for truck hauling, it was agreed that they would pay the cost of any damages done to these haul roads.

Motion is made by Comr. Morse, supported by Comr. Mavis and confirmed by Chairman Biegalle, that this now be reversed with the Forest Road 5629 having the right of way with the LaSalle Road traffic being required to stop, since the flow of traffic would be heavier and faster on the bituminous surface.

Dept., in writing, that the new section of highway, relocated US-31, is open to traffic.

Mgr. reports that the present supply of maps is down to about 1,000 copies, and commission approves the purchase of another 10,000 maps at the quoted price of \$864. and if others want a quantity of them later, such as the Chamber of Commerce and the Sheriff's Dgpt, the cost will be pro-rated to equalize the cost per thousand.

Letter received from the Dept. of State Highways, signed by James M. Falk for A.C. Sherman, Engr. of the Local Gov\*t Div., approving road commission request for the addition of Johnson Road, from Jebavy Road, west, to the Ludington City Limits; the Anthony Road from Taylor Road to Masten Road; and the Taylor Road from Washington Road to Anthony Road, to the County\*s Primary Road System; also approved was the Masten Road from the Washington Road to Anthony Road reversion to the Local Rd. system

Letter also states that they expect the horizontal alignment to be sonsideraly improved when the Anthony-Taylor Road route is reconstructed.

Discussion then was held on the union negotiation items after a meeting with them on Wed. June 26th by Mgr. Lunde and Attorney Claire. Commission recessed for lunch, aft which they are to meet with Attorney Claire in his office In Ludington for further dicussion of the negotiations. Also to review situation of marking of a dead end road in Hamlin Twp. on Dewey Road at the Middle Bayou.

Discussion on the Project No. S-4267, the culvert over the Sauble River on the Schoenherr Road, regarding the sharing of the cost. Various percentages have been mentioned regarding the share of the townships, Freesoil and Meade, but no confirmation has been received on anything different than the regular 50/50 sharing which has been the policy whenever two townships were involved, and per the minutes of the supervisors meeting on Apr. 14, 1967, a copy of the newspaper account of same was entered on 1/26/68.

Motion is made by Comr. Mavis, supported by Comr. Morse, and confirmed by Biegalle, that bills be sent to the County Cterk for the County—at—large share of this project which is \$3,270.79 or 60% of the balance left after 50% share of the Rd. Commission and the \$4,000. contribution of the Forestry Service has been deducted from the total amount of \$18,902.62; and to Freesoil and Meade Townships for the remaining 40% of the balance which is \$1,090.26 for each township.

The Primary Fund would have a balance of \$120,695.60 if the maximum transfer of \$84,70 were made; since there was an unexpended balance of \$21,432.31 in the Primary Fund at the end of 1967. No motion was made at this time to request this transfer of dunds.

2. Double seal on prepared road bases: - The Township shall buy all necessary materials and the Road Commission will pay for the application and building.

3. Bridge Program: - The Road Commission will pay 50% of this cost;

Townships 20%

This is a continuation of the previous bridge program participation, and subject to the approval by the Rodds and Bridges Committee.

- 4. Replacement of large culverts: The culverts will be purchased by the Township and the Road Commission will put them in.
- 5. Gravel programs on Local Roads will be limited to construction project agreements, or as part of routine maintenance. Actual cost of furnishing the gravel will be charged.

Mgr. reads county resolution regarding the signing of State Maint. Contract as prepared by State Hwy. Dept, as follows:

Commissioner Russell F. Mavis offered the following resolution and moved for its adoption. BE IT RESOLVED THAT the County Maintenance Contract between the MICHIS AN STATE HIGHWAY COMMISSION and the County of Mason for the period Jan. I, 1969 to Dec. 31, 1969, is hereby accepted and Robert E. Lunde is designated as Maintenance Superintenden on sections of State Trunk Line Highways and also on Bridges, said Trunk Line Highway sections and bridges being as indicated on Budget Sheets. The Board of County Road Commissioners are hereby authorized to sign the said maintenance contract. Supported by Commissioner Ivan E. Morse. ADOPTED: Yeas - three Nays - O.

This motion certified that same is a true copy as adopted at the meeting of the Board of County Road Commissioners on the 20th day of December, 1968.

On the bridge between Oceana and Mason County, the railings will be zinc coated and fixed up. Motion is made by Comm. Morse, supported by Mavis for railings to be removed and zinc coated at a pace of approximately \$500. which Oceana should share in 50/50; this motion confirmed by Biegalle. It is requested that a similar motion be made by Oceana County and Mason Furnished with a copy of same for their records.

Robert Smith of Smith and Eddy Insurance Company is in to get the statement of values on buildings and contents for the year 1969. Coverage is the same as 1968, and Chairman is authorized to sign this statement upon a motion by Morse and supported by Mavis.

Mgr. reports a reply has been received from the Local Govit Unit of the State Highway Bepartment granting permission for the transfer of 15% Primary Road Funds to the Local Road Funds per Mgrts letter of necessity.

Minutes of the Dec. 20th, 1968 meeting were read and approved as read. Commissioner Mavis requests clerk to make a comparison sheet for jobs done in 1968 to show how estin ates are comparing with actual costs.

Manager tells commission what he would like on the tandem trucks, wants a 175" wheel base; wants trucks mounted with blades on, priced at \$2600. each, wants it wa as a snow plow and blade truck, and with sander and dumpbox.

The following letter was received from the Teamsters Local No. 214, and upon motion by Morse, supported by Mavis, it is a requested that this letter dated Dec. 17th be included in the recorded minutes of this date. Letter addressed to Rd. Commission Attorney John W. Claire: Re Mason County Road Commission "Dear Sir: I am in receipt of your letter dated Dec. 21, 1968, and appreciate the fact that you are willing to enter Contract negotiations as soon as possible.

However, I find December 23rd not convenient for me inasmuch as I will be out of Detroi on another matter. I do have open dates starting Monday Jan. 6th through Jan. 10th and also the following week. I would appreciate it if a mutual date can be agreed upor within these fourteen dats.

Please notify my office of the date, time and place said negotiations may begin.
