Discussion about snowblowers. The one that has been delivered did not get here in time for the big storm, but did get a chance to do some widening. The clutch was slipping, but a factory man and a representative of the company selling the machine came and repaired it so now it is working in good shape. Road Commission would like to bill to Board of Commission according to resolution.

Thirty-five thousand (35,000) dollars has been billed, but not as year paid Was billed after last Board of Commissioners meeting. This was approx. \$20,00 for Stephens road bridge and approx 15,000 for three township road projects.

Emergency snow funds. This fund for weekend and Holiday snowplowing was setup solely for snow plowing. Would it be possible to get anything remaining in this fund set up like the previous winter's fund to be used on local road maintenance?

Road to Landfill at Scottville. The stretch of road from the end of plant mix paving near the bowling alley on First Street then west and south was double-sealed two years ago. Now it should have the third seal and Scottville(they paid on the double seal) has indicated they think the County should do something for this road as it will now be the main road to the new County Land fill. After discussion concerning upgrading this stretch to a plant mix so that it could be an "all-weather" road, the Road Commission agreed to study this from the thought of using "Local Road" construction funds.

Campbell Bridge. Discussion about Lloyd Tubbs property.

Motion by Lapenas, seconded by Riisberg, We amend the motion to purchase the Lloyd Tubbs property at the intersection of Beyer and Custer Road, we agree to pay the \$8,500 in three interest-free installments and we require all oil and/or mineral rights to be included in the transfer of ownership. Freesoil Board would like the remaining amount of gravel planned for Freeman Road put on so as to use up the number of cubic yards listed on estimate.
